rates We predict that firms substituted dividends for repurchases because the reduction in dividend tax rates exceeded the reduction in the capital gains tax rates As expected we find substitution and find that it is increasing in the percentage of the company owned by individual investors the only shareholders affected by the legislation These findings are consistent with boards of directors considering the tax preferences of individual stockholders particularly officers and managers when setting dividend and share repurchase policies
